Items of Note on the Certificate of Veterinary Inspection:

- A certificate of veterinary inspection (CVI) is required for all animals attending World Dairy
 Expo. As the CVI is current for 30 days from the date you examine the animals, the
 inspection date must be <u>after</u> August 25, 2024. For animals from outside Wisconsin, keep
 the return date in mind if the owner intends for the animals to return to the state of origin on
 this CVI.
- Consigner/Origin should be the owner, farm of origin address.
- Consignee/Destination must be World Dairy Expo, 1919 Alliant Energy Center Way, Madison, WI 53713. The livestock premises code is 004A6S7
- Official Animal Identification is required for all animals using one of World Dairy Expo's accepted 15-digit identification methods
 - o USDA 840 RFID or visual tag (for example, 840003007863940)
 - o A Canadian 124 AIN RFID tag (for example, 124002999999999)
 - A manufacturer-coded tamper-evident RFID tag that begins with 900, 982, or 985*
 - * <u>NOTE</u>: Manufacturer coded RFID tags were discontinued as official ID by USDA starting in 2015. However, tags applied before March 11, 2015 will be recognized as official ID for the life of the animal.
- Animal health testing requirements based on animal's state of origin
 - All States: All intrastate and interstate movements of lactating dairy cattle require a
 negative influenza PCR test on milk samples with a collection date within 7 days of
 movement. Requirements for Influenza testing are subject to change, for updated

- Michigan's Federal TB Free Zone and Texas: each animal must have either a negative tuberculosis test within 60 days before the date of import OR originate from an accredited TB-free herd with herd number and accreditation date on the CVI. The herd accreditation test must be within two years before the import date. There is no grace period after the expiration date. No whole-herd TB test is required. No import permit is required.
- Michigan's MA zone (Alcona, Alpena, Montmorency and Oscoda counties):
 - Each animal must have a negative individual TB test within 60 days of import and originate from a herd that has had a negative whole herd TB test within the last 12 months of all animals in the herd one year and older. The dates of both tests must be written clearly on both the import permit application form and the CVI.
 - The CVI must contain a statement that the animals are attending the show only and will return to the state of origin after the show.
 - Animals are eligible to participate in sales; however, they must return to their state of origin after World Dairy Expo and then travel to their new owners in compliance with the import requirements of the state of destination.
 - An import permit must be obtained from the Wisconsin Department of Agriculture, Trade and Consumer Protection (DATCP) before the animal enters Wisconsin. For more information, call 608-224-4872 or go to https://datcp.wi.gov/Documents/GeneralImportForm.docx
- All other states: No TB testing is required at the time of this publication.
 Requirements can change. For the latest information by state, call 608- 224-4874 or go to https://datcp.wi.gov/Pages/Programs Services/WorldDairyExpo.aspx.
- Outside the United States: Animals will need to meet the import requirements established by the United States Department of Agriculture (USDA). You can learn more by calling the National Center for Import and Export at (301) 851-3300 or go to https://www.aphis.usda.gov/live-animal-import.
- No other tests or statements are required, unless otherwise noted.
- No permits are required, unless otherwise noted.
- If there are problems with the paperwork, the animals will be moved to an isolation area until corrected health papers arrive:
 - If animals do not have a CVI, whether traveling from Wisconsin or out-of-state, the animals will remain on the trailer in the isolation area until a completed CVI arrives or be required to return to the farm of origin.
 - If the CVI has expired, the animals will remain on the trailer in the isolation area until a CVI is received with the correct inspection date or be required to return to the farm of origin.
 - If the TB test is expired or missing, the animals will remain on the trailer in the isolation area until a corrected CVI is faxed. If no TB test proof is provided, the animal may not show and must leave Wisconsin.
 - If cattle from Michigan's MA zone have no import permit, the animals will remain on the trailer in the isolation area. The exhibitor/veterinarian will need to contact the Wisconsin Animal Health Officials to notify them of the import violation.

It is the exhibitor's responsibility to stay informed of any status changes or modifications that may have an impact on their trip to World Dairy Expo.
